



2021-22 Yellow Ribbon Program Information and Application

Crown College partners with the Department of Veterans Affairs in supporting our veterans by participating in the Yellow Ribbon Program. To be considered for this program, you must be a current student in good academic standing or be officially accepted for admission to Crown College AND have received a Certificate of Eligibility (COE) from the Veteran's Administration verifying you are eligible at the 100% level for Chapter 33 benefits.

Recipients for the Yellow Ribbon program will be selected on a first-come, first-serve basis based on the date a completed Yellow Ribbon application is received at Crown College. Only complete applications from students who have been admitted to their program will be considered.

The Veteran's Administration (VA) will provide each Chapter 33 benefit recipient with a tuition and fee benefit capped at **\$25,162.14** (waiting for the updated tuition amount). Crown College will provide funding up to a maximum annual benefit to its Yellow Ribbon recipients which may not exceed 50% of the remaining tuition and fee charges. The VA will match the contribution made by Crown College. A Yellow Ribbon award will replace all other Crown College funding including academic scholarships.
